

Introduction

This privacy notice explains how and why Specialist Risk Group (SRG) collects and uses the personal data when you register for and attend our events. This notice applies only to personal data processed in connection with event registration and attendance and n does not apply to personal data processed in the course of risk placements.

Collection and Use of Personal Data

When registering for our events, we ask for details that contain personal data. This includes standard personal data i.e.name, job title, company name, contact information (including phone number and email address). In some circumstances we may ask for special category data such as dietary or health (for access requirements). Providing this information is optional but may be necessary to enable us to meet your specific requirements.

Where you provide us with details of others (colleagues, family and friends), you do so with the knowledge of the person noted. Please share a copy of this notice with them.

Please note that photographs and/or videos (collectively 'Recordings') may be taken during our events. SRG may use such Recordings in internal and external communications, as well as for event management purposes. This could be in print and online (including social media).

Lawful Basis for Processing

We process your personal data lawfully and rely on legitimate interest for the purpose of organising and administering events, managing attendance and communicating with attendees.

Where we process special category data such as dietary or accessibility requirements, we rely on your explicit consent under UK General Data Protection Regulation (GDPR) to do so.

We may take photographs and/or video recordings at our events for legitimate business purposes, including internal communications, event administration and marketing or promotional activities (including on our website and social media channels).

We rely on our legitimate interests under UK GDPR to do so. Where Recordings focus on identifiable individuals (such as interviews or close-up images), we will seek consent where appropriate.

Sharing Personal Data

We share your personal data with others including:

- Joint host(s) of the event, (where applicable this will be clear in your invitation to register for the event).
- Certification bodies to register your attendance for CPE credits.

Where we use an external venue or catering company, we may share with them any dietary or access requirements that you provide us where required, so that we can meet your needs. Where third parties process data on our behalf we ensure appropriate contractual safeguards are in place. Further details about third parties used by SRG; please contact hello@specialitrisk.com.

Security

We put in place measures to protect the confidentiality and security of your personal data, and to comply with our data protection, confidentiality, and security standards.

We are committed to protecting and respecting your privacy. We will only share your personal data with others, including companies within the SRG group, when we are legally permitted to do so.

Data Transfer

We may need to transfer your data to other companies, including within the SRG group, located outside of the UK and/or European Economic Area. Those transfers would always be made in compliance with data protection legislation, i.e by use of adequacy decisions standards contractual clauses SCCs or UK international data transfers agreements IDTA.


Data Retention

We do not keep information longer than necessary and when it is no longer required, we will securely delete or anonymise it.
